The Quotation should be submitted by 10:00 AM on 29th of July, 2021 & the same will be opened at 12.00 AM on the same day at the chamber of Additional District Magistrate (Development). Interested bidders may remain present at the time of opening of the Quotation.
5. The District Magistrate, Cooch Behar reserves the right to relax any of the aforesaid criteria, at any stage of process on specific ground. Also he reserves the right to cancel any or all the applications, without showing any reason thereof.
