

Quotation is hereby invited by the Chief Medical Officer of Health, Cooch Behar from reputed and experienced firm or agencies for the following work at CMOH office, Cooch Behar.

Name of Work : Providing Ply partition wall at Dy. CMOH-II office inside the CMOH office, Cooch Behar
Specification : as per "Annexure 'A'"
Completion Period : 7 days from the issuing date of work order

The agency should thoroughly inspect the site and submit the quotation as per specification. The rates shall be inclusive of all charges i.e. labour, hire of tools, carriage, all kind of taxes, etc. The intending bidders are requested to collect the specification (BOQ) from the office of the undersigned during office hours up to 3.00 p.m. of 27.01.2021. The last date of submission of quotation is up to 5.00 pm of 27/01/2021 and the same will be opened on 28/01/2021 at 12.00 noon at the chamber of the undersigned.

Eligibility criteria for participation in tender:

The applications must be accompanied with the following documents.

- a) Bonafide, resourceful contractor who have satisfactorily completed at least one similar nature of work duly started and completed within last 3 (Three) years from the date of publishing of this NIQ as a prime agency in Government/ Semi-Government Dept. having value of work not less than 40% of amount put to BOQ.
N.B:- No credential will be considered unless it is supported by Completion Certificate or Final Payment Certificate along with Work Order clearly mentioning the estimated amount, final billing amount, date of commencement and completion of the work and details of communication address of the Issuing Officer i.e. head of the office of the concerned department.
- b) Earnest Money Deposit in amounting to Rs.1,000.00 only in the shape of Bank Draft / Pay Order from any Nationalized Bank drawn in favour of the "**Secretary of DH&FW Samity, Cooch Behar**" against the works. This clause is also applicable for all categories of applicants except those are exempted as per Government Order no. 1110F, dated 10/02/2006 of Special Secretary Finance Department, Govt. of West Bengal
- c) Trade License valid for the FY 2020-21.
- d) PAN along with Income Tax Return for the AY 2020-21 / Professional Tax Registration Certificate along with Challan for the AY 2020-21 / GST Registration with return up to September, 2021 / Photo ID Proof for self identification to be accompanied with Technical Bid documents, which is to be submitted in separate sealed envelope superscripted with "Technical Bid"
- e) Registration Certificate under Companies Act and Article of Association & Memorandum (if any).
- f) Registered Notary Deed to be submitted by the Partnership Firms.
- g) A Registered Engineers or Labour Co-Operative Societies Ltd. is required to furnish valid Bye Law and Renewal Certificate duly certified by ARCS.
- h) Power of Attorney to be submitted by the Engineers or Labour Co-Operative Societies, Partnership Firms and Private Limited Companies.
- i) Joint Ventures will not be allowed.

Financial proposal:

The financial proposal to be submitted in a separate sealed envelope superscripted with “Financial Bid” mentioning the offered rate as amount in the prescribed format of specification as per “Annexure- A”

General guidance to the bidders:

The bidding will be executed in two bid system. The agency should ensure that the Part-I: ‘Technical Bid’ completed in all respects and containing the required enclosures is sealed in a separate cover and Part-II: ‘Financial Bid’ is also sealed in a separate cover and the both envelopes are kept and sealed in a suitable size cover which is addressed to the ‘Chief Medical Officer of Health, Cooch Behar’ superscripted in block letters with ‘Name of the work’ and ‘Quotation No.’ The Technical bid and Price bid should also be separately superscripted. The tender shall be deposited in the tender box provided in the Accounts section at the office of the Chief Medical Officer of Health, Cooch Behar at Lal Bag, Debi Bari Road, PIN-736101 by the due date and time.
