
Term and condition:-

- (1) An amount of Rs.6,000.00 (Rs. Six Thousands only) is to be given as earnest money by way of Crossed Demand Draft in favour of Secretary, District Health and Family Welfare Samiti, Cooch Behar.
- (2) Rate should be quoted inclusion of all taxes and POL for carrying goods only (it must not be more than @Rs.50/KM to & fro) .
- (3) Separate rate should be quoted for loading and unloading purpose (it must not be more than @Rs.3/Per left/cartoon).
- (4)The vehicle must have commercial tax registration of current validity.
- (5) Required Papers :- (A) For individual bidders:- (Self attested photocopy of) Commercial Tax registration certificate, Insurance, Pollution, PAN No, GSTN No. (B) For Agency/Firm-(Self attested photocopy of) Trade licence, PAN No & GSTN.
- (6) Tender should be valid for one year from the issue of work order.
