Superintendent Cooch Behar District Correctional Home invites application **for engagement of a whole time contractual Medical Officer for a period of 01(one) year** from the date of engagement for Cooch Behar District Correctional Home on the following terms & condition.

Terms & Condition:-

- 1) **Age-** Not Below 27 year & above 65 Year as on 01/01/2018. Period of contract must not exceed the date on which he/she attains age of 65 Year.
- 2) **Qualification:** - Must be M.B.B.S from any recognized institution /medical college, recognized by the medical council of India having at least one year house staff ship.
Must be registered as medical practitioner with the medical council of India or West Bengal medical council. Must be a citizen of India & resident of the state continuously for at least 10(ten) years. Preference may be given to local candidates. Medical Officer as selected will be a man of clean image & reputation.
- 3) **Selection Procedure:-** Engagement of contractual Medical Officer & its subsequent renewal will be made on the basis of the recommendation of selection committee, to be constituted by the OSD & Ex-officio DG & IG of Correctional Services ,W.B. in the following manner -
 - 1) District Magistrate or his representative not below the rank of ADM/Senior Deputy Magistrate in charge Of affair of Correctional Home - Chairman.
 - 2) Chief Medical Officer of the district or his authorized representative - Member
 - 3) Superintendent Cooch Behar District Correctional Home - Member.
 - 4) Any other Correctional Home officer, holding the rank of DIG of Correctional Services or AIG of C.S.W.B as may be nominated by the OSD & Ex-officio DG & IG of C.S.W.B if he so desires - Member.

Selection committee shall submit their recommendation to the OSD & Ex-officio DG & IG, C.S.W.B for onward transmission to the Government with his specific views on such recommendation.

5) General Terms & Condition:-

- a) Medical Officer so selected will be eligible for drawal of pay @ Rs. 21000/- (Twenty one thousand) only per month including grade pay of fixed initial basic along with admissible allowances except non-practicing allowance.
- b) The nature of engagement of Medical Officer on whole time contract is purely temporary and contractual basis and this contractual assignment will not confer upon any right on him/her for consideration for any future employment in this Correctional Home or anywhere in the Govt. of W.B in any similar or related capacity.
- c) The period of contract at a stage will not exceed 01(one) year from the date of joining to the post or the date on which he attains the age of 65 Years of old whichever is earlier .
- d) It is preferable that M.O. will have to stay in the Government accommodation with in the Correctional Home premises to availability of accommodation and he will not be eligible to draw H.R.A in that case. .

Till such accommodation is not provided, he/she will have to arrange on his /her own to stay 2 K.M from the Correctional home so that he/she may remain present at his/her working place on emergency call at any time.

- 6) The selected Candidate will have to submit an undertaking to the effect that he/she will have to abide by all terms & condition of the contract as imposed by the authority.
