Terms & Conditions:

- (i) The security personnel deployed has to be with sound health and no criminal complications & clearance of CA has to be obtained from local Police station..
- (ii) Rate to be quoted for 24 hrs. services for 365 days.
- (iii) The agencies should have the registration under Labour laws. All legal compliance will be responsibility of the agency.
- (iv) The agency shall provide security services by deploying adequately trained and well disciplined security personnel, who shall safeguard the Training Centre building, movable and immovable assets, equipments and other items at the above address from any thefts, pilferage or damage and also ensure safety of the trainee, employees, visitors, guests or any other persons working in its premises.
- (v) The agency shall supervise the cleaning of the premises and water pump operation.
- (vi) The security personnel shall be duly trained in Fire Safety Operations. They should be trained to operate various fire control equipments installed at the training center.
- (vii) It shall be binding on the agency that it does not directly or through its security personnel divulge any secret or sensitive information of the Office of the undersigned which comes to their knowledge in the discharge of their duties.
- (viii) The undersigned will make payment to the agency per month as per agreement contract.
- (ix) In case of any loss or damage caused to the property of office of the undersigned where involvement of security personnel is proved, compensation so finalized is to be paid by the agency.

- (xi) The period of contract shall be two years with effect from the date of signing of agreement.


