Sealed quotation will be open on 02.06.2021 (Wednesday) at 4 pm or any other subsequent date as deemed fit by the authority, at the Chamber of Additional District Magistrate (Dev.) & Additional District Programme Coordinator, Mahatma Gandhi NREGA, Cooch Behar. Intending participants may remain present during opening of quotations.

Terms & condition are as under:

- The intending agencies have to submit the self-attested copy of PAN Card, GST Registration, I T Return (Last 03 years) P. Tax Certificate, Valid Trade License, Credentials Certificate (At least 01 work experience in any Government Organization within last 3(three) Financial Year) as part of TECHNICAL BID in a separate sealed envelope.
- 2 The rate offered should be on their own letter head clearly mentioning the item wise rate duly signed by the intending quotationers in a separate sealed envelope marked FINANCIAL BID.
- 3. The technical bid will be opened first and will be evaluated. The financial bid of the eligible quotationers only may be opened after that on the same day or on a future date.
- 4. Quantity of items may vary, for which no change of rate will be allowed.
- 5. The applicant should state the quoted rate clearly in gross for each item (inclusive of all expenses like material cost, labour charge, transport charge, GST etc all) for completing the work as specified.
