1. CAMC in respect of 16 sets CCTV – Cameras including its cable / wiring.
2. Allied accessories / spare parts of those CCTV Cameras as noted above.
3. Supply of CCTV Footage as and when required during the mentioned period of CAMC.
4. The rate should be quoted both in figure and words excluding of **GST. GST % should be mentioned separately at prescribed column.**

**Earnest money : Rupees Ten Thousand ( Rs. 10,000.00)** only as Demand Draft from any nationalized Bank in favour of Rogi Kalyan Samiti, MJN Hospital, Cooch Behar.
