

The said quotation papers will be opened on 16/07/2020 at 3.00 PM at the office chamber of the Medical Superintendent cum Vice Principal.

1. The quotation shall have to quote the offer rate of each medicine/reagent in figure and words clearly on an official pad.
2. Rate should be quoted, inclusive of all type of charges/GST etc. per unit as specified in above.
3. All the valid papers must be submitted along with quotation i.e. I. Tax/ Professional Tax/ drug licence/valid PAN card/Trade Licence Certificate/GST certificate with proper attestation.
4. The supply order will be given to the successful bidder as selected by the selection committee and supply should be made within 7(seven) days from the date of issue of the supply order.
5. The selected party/Firm will be fully responsible for supply of the items to Cooch Behar Government medical College & Hospital.
6. The bidders should have the experience of supplying such items at Govt. Offices/ Hospital.
7. The items to be supplied by the successful quotationers should have an expiry date not less than 12 months from the date of supply.
