NOTICE INVITING e-TENDER

e-Tender is invited for the Selection of **DIAGNOSTIC CENTRE** (s) for Pathological Test by the Superintendent Cum Vice Principal MJN Medical College and Hospital, Cooch Behar.

The Superintendent Cum Vice Principal, MJN Medical College and Hospital, Cooch Behar, having its office at Silver Jubilee Road, Cooch Behar – 736101 is inviting e-Tender in Two bid System for the Selection of diagnostic Centre /Pathological Laboratory for providing Laboratory investigations as advice for the Indoor patients of this Hospital which are not available at this facility. The details list of the tests is also stated in the enclosed sheet. The rate is to be quoted item wise as per BOQ.

The sample for testing are to be collected daily basis from this Hospital and the Report along other papers if any are to be submitted within 24 hours/ as soon as possible (for Special Tests) at this Hospital.

The agency should have local office at Cooch Behar Town so that communication may be done when required with the agency for the collection of Sample as well as submission of Reports. Collection of Samples and Delivery and Delivery of Reports should be arranged at MJN Medical College & Hospital.

The intending bidder will have to deposit Earnest Money of Rs 25,000/- in form of Demand Draft in favour of the MSVP, MJN Medical College & Hospital payable at Cooch Behar.

WITHDRAWAL /CANCELLATION: 6.

The authority reserves the right to withdraw or add any item from the Tender at any stage. The selection of such item, if already made in favour of any the Tender shall be treated as cancelled. The authority reserves the right to reject or accept any Bidder or part thereof at any stage or to split any Tender without assigning any reason. Withdrawal of Tender or any revision after submission of Tender by the Bidder will not be allowed. 8. APPEAL:

The Special Secretary/Secretary/Principal Secretary will be the appellate authority within the Department of Health & Family Welfare, Government of West Bengal.

9. AGREEMENT:

After the acceptance of the Tender, intimation of acceptance will be forwarded to the Successful bidder by MSVP, MJN Medical College& Hospital, Cooch Behar, West Bengal. After communication of the same, the Successful bidder and the selected bidder shall have to execute bilateral agreement with the MSVP, MJN Medical College & Hospital, Cooch Behar after making payment of Security deposit of Rs Two Lakhs (Rs 2,00,000/-) in form of Bank Guarantee. The Security money will be kept for the entire period till validity of agreement.

10. **VALIDITY PERIOD OF AGREEMENT:**

The contract period will be valid up to 3 years from the date of execution of agreement. It may be extended as per decision of the authority.

11. **COLLECTION CENTRE:**

One collection centre is required to be set up within the Hospital premises which would function on round the clock basis by the Successful bidder. The Electricity charges will be borne by the Implementing Diagnostic Centre. Separate Electric meter to be installed. Donal

The list of investigations to be done will be provided by the Hospital Authority as and when required. Only laboratory investigations which are not are not available at this facility are to be done as provided time to time by the hospital authority.
