**A. General:**

1. Plan should have to be submitted in hard copy as well as soft copy a) Size of hard copy should be at least 84.1 cmx118.9 cm (A0) in 05 sets in each market yard. b) Soft copy in Auto CAD in 03 CD at least for each market yard.
2. Information of Land including other features should be supplied from this end, as per availability.
3. Quantum of Vacant land should be noted for different land in separate sheet with GPS location.
4. Intending person may visit P.M.Y. & S.M.Y. on any day or contact with the In charge on working days.
5. Time allowed for completion should be strictly followed by the eligible person, which reckoned from the date of work order.
6. Field work should be conducted without hampering normal activity of the market yard.
7. The intending person/ farms are requested to submit their experience certificates of similar nature of works.
8. Contour survey may also be done as per necessity of the market yard as directed by E.I.C.


