**Expression of Interest (EOI) for providing with different services like Therapeutic support/Orientation of sign language/Identification and Assessment Camp of Low Vision not yet identified/Extending Corrective Surgery/Supply of Low Vision Aids & Appliances/Hearing impairment support/Minor repairing of hearing aids etc. for children with special need (CWSN) under Paschim Banga Samagra Shiksha Mission, Cooch Behar**

Expression of Interest (EOI) are invited by the District Education Officer (DEO), Paschim Banga Samagra Shiksha Mission, Cooch Behar, West Bengal (erstwhile DPO, SSM, Cooch Behar) from the bona fide Non Govt. Organisations with sound pre-requisite eligibility criteria and Qualification of Rehab/Medical/Technical/Professional attached to the NGOs in providing with different services like Therapeutic support/Orientation of sign language/Identification and Assessment Camp of Low Vision not yet identified/Extending Corrective Surgery/Supply of Low Vision Aids & Appliances/Hearing impairment support/Minor repairing of hearing aids etc. in the Government Department/ Government Undertaking/ Semi-Government Organisation under two bid system ( Technical Bid & Financial Bid).

**Eligibility criteria for selection of NGOs:**


1. Firstly, the concerned NGOs should have certain **pre-requisites** to become eligible to apply who have:
  - (i) Registration as per Indian Societies Registration Act, 1961.
  - (ii) Working experience at least five years in disability field.
  - (iii) Registration of the organization as per PWD Act, 1995.
2. Secondly, NGO(S) should have qualified Rehab Professionals like different Therapists, Psychologists, Audiologists, Optometrists, Sign language interpreter, Ear mould technician as per prescribed qualification of Rehabilitation Council of India of MSJ& E, Gol for the same or they may hire their services to deploy for the purpose and befitted qualification of medical practitioners as has been prescribed by Medical Council of India.
3. The authority in the District Project Office (DPO) in the Paschim Banga Samagra Shiksha Mission is the District Project Director, SSM, Cooch Behar.
4. **The District Project Office (DPO) is not bound to accept always the lowest offered rate(s) and reserves the right to accept or reject any or all the proposals without assigning any reason whatsoever. The authority also reserves the right to split the jobs amongst the NGOs, if deems fit and expedient without assigning any reason, whatsoever.**
5. Rates should be quoted by the intending NGOs in both figures and words and in accordance with the above criteria, mentioning the completion time. Detail break up of rates) is required to be mentioned in the offer.
6. Corrections, if any, in the offer should be initialed and dated by the NGOs before submission of offer. Each page of the offer documents must be signed by the authorized signatory of the concerned NGO.
7. **Estimated Work Value is Rs. 499000/- (INR four lakh ninety nine thousand only). An amount of Rs.10000/- (INR ten thousand only) need to be deposited in favour of the District Education Officer, Paschim Banga Samagra Shiksha Mission, Cooch Behar during submission of proposal as Earnest Money in the form of Demand Draft. Earnest money will be subsequently converted into security deposit in case of successful bidders. Security deposit will be 8% of the work value.**

8. Canvassing in any form or for any pecuniary interest is strictly prohibited and the rate submitted by an NGO, who resorts to canvassing shall be summarily rejected without any further correspondence.
9. **The Final approval of the selected NGOs will be given by the State Authority. The recommendation of the District Committee on the engagement of NGOs to be placed to State Authority for final approval.**
10. Successful NGOs shall allow the authorized representatives of the DEO to visit his office, as and when necessary.
11. The Authority reserves the right to review the performance of NGOs periodically through its authorized representatives having experience and expertise in the field. If on review, performance of any NGO is found to have been dissatisfactory, the authority shall reserve the right to cancel the agreement with the concerned NGO and decision thereon of the authority shall be final and binding upon that NGO.
12. Incomplete applications or application received without the desired documents shall be summarily rejected, without making any further reference/ correspondence.
13. For any kind of dispute – Kolkata High Court will be the legal jurisdiction of the agreement.
14. Applications must be submitted in the official pad of the NGO duly addressed to the District Education Officer, Paschim Banga Samagra Shiksha Mission (PBSSM) Cooch Behar District signed by the authorized signatory mentioning clearly his contact no., exact postal address of the NGO and Email address, if any, etc.
15. Last date for submission of Application is within 29/07/2019 up to 3.00 p.m. The applications will be opened for enlisting at 4.00 p.m. on the same day. Only authorized representatives of participating NGOs may remain present during enlisting of applications.




**Proposals (along with physical & financial involvement and target date) should be submitted in official pad supporting the documents required for the points mentioned below to the District Education Officer, PBSSM, Cooch Behar District within 29.07.2019 other terms & conditions as has finalized and mentioned above:**

1. Name & Complete address of the organization.
2. Date of establishment of the organization.
3. Nature of the organization (types of services rendered).
4. Brief history of the organization and of its objects & activities.
5. Registration No. of the NGO registered under Societies Registration Act 1961. (copy of Registration to be enclosed).
6. Registration No. of the NGO registered under PWD Act (Persons with disabilities Act). 1995 (copy of valid Registration of the NGO as per PWD Act. 1995 to be enclosed).
7. Details about working experience in disability field (copy of supportive document showing working experience in disability field at least for five years in disability field to be enclosed).
8. Details about working experience with SSA Activities (if any, documents to be attached).
9. Whether the organization runs in its own / rented building.
10. Whether the organization conducting training programme for manpower development (if so, details to be attached).
11. Details of staff working mentioning professional qualification & experience against each.
12. Documents :
  - a. Annual report including audited accounts for last 3 years.
  - b. Constitution / by-laws of the organization.
  - c. Constitution of the Board Management and the particulars of each member.
  - d. Copy of PAN Card of the organization.
13. Tenure of involvement: Initially NGOs will be selected for one year. NGOs having satisfactory performance may be continued for the next financial year or fresh proposal may also be invited to select new NGOs. This involvement of NGOs/Resources will be purely temporary and the payment may be made on session / assignment basis.
