2. Quotation to be submitted with photocopy of certificate of IT, Trade Licence, Credential Certificate of last 3 years.
3. The tenure of agreement for the above mentioned "Security cum Support Staff" and "Sweeper" with the agency will be for 1 year or may be terminated earlier with a notice of 7 (seven) days and extension of the agreement will depend on the consideration of the esteemed authority.
4. The monthly rate of the above mentioned "Security cum Support Staff" and "Sweeper" shall not be more than MGNREGA Unskilled wages rate.
5. The agency shall be responsible for ensuring
  - i. Engagement of one sweeper on daily basis- twice in the forenoon and afternoon to clean the office and toilets.
  - ii. Engagement of Security cum Support Staff in (3) three shifts for round the clock service.
6. The agency has to ensure able-bodied men with fit and proper character antecedents and Security cum Support Staff to be in uniform to serve daily with proper office decorum.


